



## Your 2023 SENSUALITY CRUISE Booking Terms & Conditions

**PLEASE NOTE: ONCE PLEASURE POINTS TOURS ACCEPTS YOUR BOOKING BY PROVIDING YOU A BOOKING CONFIRMATION NUMBER, THEREOF A CONTRACT IS MADE BETWEEN PLEASURE POINTS TOURS AND YOU.**

On receipt of your hold deposit, subject to availability & at our discretion, Pleasure Points Tours will reserve your place on this exclusive 2023 SENSUALITY CRUISE. A contract is made only between you & us upon your booking being confirmed & accepted by us & our confirmation number is provided to you. A \$52 non-refundable booking fee will be automatically added.

### PRICE GUARANTEE:

Prices in our marketing materials and online brochures are based on costs & exchange rates as of August 1, 2022. Should these costs change, it may be necessary to make a surcharge on the price of your 2023 SENSUALITY CRUISE. Should the total trip price increase by more than 10%, you will have the right to cancel within seven days of notification without penalty. No surcharge with respect to cost or currency fluctuations will be made once payment of the holding deposit for your land trip has been received. This guarantee excludes fuel surcharges & does not apply to any taxes, charges or levies imposed by any government or their agencies. In exchange for these guarantees, no refund will be made if costs are reduced.

### IF PLEASURE POINTS TOURS CANCEL OR CHANGE YOUR 2023 SENSUALITY CRUISE BOOKING :

Pleasure Points Tours reserves the right to change or cancel your booking in accordance with operating requirements or circumstances beyond its control.

Should change or cancellation prove necessary, we will give you reasonable notice thereof, in the circumstances, and where available, offer you a comparable alternative.

If an alternative is not available or acceptable, you will be entitled to either a full refund of monies paid by you to us for the REGISTRATION (ACTIVITIES) fee deposit (estimated at approximately \$700) ONLY or transfer to another Pleasure Points Tours trip without payment of any transfer fee, minus the \$52 non-refundable booking fee. Please allow 6-8 weeks for your refund to be processed.

If the change or cancellation is due to force majeure (i.e., circumstances like political unrest, war or threat of war, riots, civil strife, closure of airports or ports, industrial disputes, terrorist activity, natural & nuclear disasters, fire, Covid-19 or any other epidemic or health risks, Acts of God, adverse weather conditions or other similar events beyond Pleasure Points Tours' control), we will give a full refund of any monies paid to us for the REGISTRATION/ACTIVITIES deposit (estimated at approximately \$700) ONLY less reasonable expenses or non-refundable deposits & payments incurred by us in respect of your booking. At no time is the \$52 booking fee refunded.

Pleasure Points Tours is not responsible for the costs of any other travel arrangements affected due to our cancellations or rescheduling of any trip departure.

### 2023 SENSUALITY CRUISE DETAILS & CONDITIONS:

The information in our marketing materials and online & e-brochures is correct to the best of our knowledge when going to print (August 1, 2022). Still, we cannot guarantee that any one item or amenity mentioned will be available especially where we have no direct control over it. Pleasure Points Tours strives to improve trip itineraries & features. If such improvements can be made, or unforeseen circumstances beyond our control make changes necessary, we reserve the right to vary itineraries & substitute hotels or trip components.

All rooms, cabins, and staterooms are double occupancy. Pleasure Points Tours will match you up with someone of the same sex when booked in a double occupancy/shared room configuration where possible if you do not designate a cabinmate. We will never book you in a room with the opposite sex unless expressly instructed to do so.

Tickets & other documents won't be forwarded to you until we have received full payment. The documentation will be sent approximately 10-14 days before your departure.

In the case of late bookings made within 30 days of your departure date from the US, the full cost of the 2023 SENSUALITY CRUISE will be payable immediately on booking & we reserve the right to provide all travel documents at the traveler's departure point.

Pleasure Points Tours reserves the right to cancel the booking & apply cancellation charges should payments not be received within the specified periods or according to the agreed-upon payment schedule.

### IF YOU CANCEL YOUR 2023 SENSUALITY CRUISE BOOKING:

We know that travel plans can change. If you need to cancel for any reason, your deposit will remain secure until you're ready to use it. Or if you can't go, your registration fee deposit value is also transferable so you can gift your deposit to someone else at no extra cost. At no time is the \$52 booking fee refunded.

The value of the original registration fee deposit can be used as credit toward booking a new trip. The original deposit refers to the REGISTRATION (ACTIVITIES) fee deposit (estimated at approximately \$700) ONLY and excludes your stateroom on Celebrity Cruises or any additional deposits such as excursions, transfers, or flights. Any discounts already refunded are not applicable.

**Celebrity Cruises has set its cancellation fee policy for cabin cancellations, name changes, etc., outlined on your cruise payment document. Celebrity Cruises' cancellation fee policy is not controlled by Pleasure Points Tours.**

If you cancel more than 180 days before departure, fifty percent (50%) of the REGISTRATION (ACTIVITIES) fee deposit (estimated at approximately \$700) paid to Pleasure Points Tours and all of your booking fee is forfeited. Upon later cancellations you will be liable to pay a fee to cover the estimated costs & expenses incurred by us in terms of the schedule set out hereunder. This is expressed as a percentage of the 2023 SENSUALITY CRUISE

REGISTRATION (ACTIVITIES) fee deposit (estimated at approximately \$700) price & is calculated as follows:

PERIOD OF NOTICE PRIOR TO	CANCELLATION FEE
Over 180 days' notice or more	50% of the registration fee deposit & entire booking fee is forfeited
120-179 days	60% of the registration fee deposit & entire booking fee is forfeited
90-119	80% of the registration fee deposit & entire booking fee is forfeited
Less than 90 days	100% of the registration fee deposit & entire booking fee

Where the percentage cancellation fee is less than the trip deposit, the cancellation fee will equal the loss of deposit. If the reason for the cancellation falls within the terms of any travel insurance policy you may hold, then any such charges may, subject to the terms of your travel insurance policy, be refunded to you by the insurance company. All cancellation policies are valid as of August 1, 2022, and are subject to change. The final policy will be re-confirmed at the time of booking.

Any cancellation of additional services booked prior to or after your trip, such as excursions, services, pre or post accommodations, and transfers canceled within 14-days of the trip departure incur a 100% cancellation fee.

During your trip if you or your travel companion (booked under the same booking number) leave at any time during the trip for personal reasons, sickness or be required to return to the United States due to injury, illness or death, you and your travel companion are solely responsible for the cost for their airline ticket, lodging & meals for their early or later departure back to the United States, and all deposit and fees are forfeited.

#### IF YOU CHANGE YOUR BOOKING:

If after your booking has been confirmed, the guest is not allowed to change to an alternative date. However, a change within 90 days of the original trip departure will be treated as a cancellation and standard cancellation fees (as outlined above) will apply.

#### TRAVEL INSURANCE:

Pleasure Points Tours highly recommends that guests purchase travel insurance. #### TRAVELING WITH DISABILITIES:

Pleasure Points Tours welcomes all travelers including those with special needs or disabilities. However, please note the following:

Travelers are required to advise Pleasure Points Tours in advance of any physical, medical or special needs that require accommodation.

All travelers must ensure that they are physically and medically fit for travel. Pleasure Point Tours may impose safety requirements necessary for the trip's safe operation. We may also exclude an individual from participating in the journey or specific activity if that individual's participation poses a direct threat to their health and safety or to other guests.

Pleasure Points Tours does NOT provide personal devices or equipment (such as wheelchairs, lifts, prescription or special glasses, animal or human personal guides, etc.) or services of a personal nature such as pushing wheelchairs or assistance in eating, personal hygiene or dressing. A guest companion capable of providing such services must pay for their trip to accompany any traveler requiring such services.

Pleasure Points Tours does not employ medical personnel. Any necessary medical attention will be provided by the ship's medical staff, a local facility or a provider at the traveler's expense. These parties are independent entities of which Pleasure Points Tours has no control and is not responsible or liable for losses or costs incurred from medical services obtained while on this 2023 SENSUALITY CRUISE or the quality of care.

Travelers should be aware that some portions of this trip may include inclement weather, rough/unfinished terrain, extensive walking over uneven pavement, streets, sideways steps and locations which may not be easily accessible or accessible by wheelchair, walkers, or even personal cane use. Pleasure Points Tours cannot guarantee disability cabins, access or accommodations for disabled travelers.

**SMOKING:** All Celebrity Cruise ships have a no smoking policy. Pleasure Points Tours does not tolerate nor permit the possession or carriage of illegal or restrictive substances (including drugs, prescription drugs not prescribed to you, drug paraphernalia, etc.). As of this writing, CBD, THC and other cannabis products are prohibited on board Celebrity Cruise ships. Travelers will be responsible for any costs incurred in the event that the traveler must be removed from any transfer, excursion or trip. Travelers agree not to hold Pleasure Points Tours or its related entities liable for any actions under these stated conditions.

Guests are solely responsible for any costs incurred due to damages or excess cleaning fees related to your cruise accommodations, excursions or transportation. Guests must immediately notify Pleasure Points Tours staff and Celebrity Cruise staff of any existing damage as soon as it is discovered.

Any threats to the Pleasure Points Tours staff's safety or well-being or inappropriate behavior by you, whether verbal or physical will be taken extremely seriously and may result in the immediate termination of this trip. In any event the guest will be responsible for their own repatriations and related costs and will have no claims against us.

Where the traveler occupies the ship's tender or a motorcoach seat, fitted with a seat belt, neither the operator nor service provider, agents or co-operating organization shall be liable for any illness, injury or death or any loss, damages or claims whatsoever arising from any accident or incident if the seat belt is not being worn at the time of the accident or incident.
